## PERSONAL DATA IS PROCESSED

#### SHARE WITH OTHERS

NVBK vzw only provides your personal data to third parties if this is necessary for the execution of an agreement, our regulations, or to comply with a legal obligation.

## **CREATE WEBSITE VISIT**

On the website of NVBK vzw general visitor information is kept, including the IP address of your computer and the time of retrieval and data that your browser sends. This data is used for analyzes of visitor and click behavior on the website. NVBK vzw uses this information to improve the functioning of the website. This data is anonymised as much as possible and is not provided to third parties.
